- _____ 1. PARADE ENTRIES MUST FOLLOW THE DIRECTIONS OF PARADE OFFICIALS.
- _____ 2. Entries must be appropriate for a family audience.
- _____ 3. Entry will not be focused on controversial religious, political, ideological themes or issues. Use of any political sign, social or political material or improper use of the American flag is not permitted.
- _____ 4. The American Flag has specific rules for display. Proper use of the flag is based upon the U.S. flag policy set forth in the U.S. Code. Please visit the following link to make sure you show proper respect for the flag and what it stands for.

- _____ 5. Livestock, domestic animals, birds, reptiles, or other animals are permitted in parade vehicles under the owner's control. There are special rules for equestrian riders and must be approved by the Parade Steering Committee and may be subject to restrictions.
- _____ 6. An entry with a commercial sponsor may display the commercial sponsor's name on both sides of the vehicle. Size is not restricted but must be appropriate to the size of the vehicle. Signage restrictions also apply to towed vehicles. Signage which violates restrictions will be removed by parade officials.
- _____ 7. This is an "all forward motion" parade. Parade participants must keep pace with the line of vehicles. No backing-up or any other maneuver contrary to the forward progress of the parade is allowed.
